

**Greektown SSA #16  
Emergency Board Up Grant Application**

**1. Description**

Provides up to 100% of cost (or to cover cost of insurance deductible), up to \$1,000 maximum payout, for labor and materials to clean-up and board up your storefront doors, doorways and windows if your property sustained damage due to vandalism or looting.

**2. Eligibility**

Eligibility is open to building owners and tenants located within the Greektown Chicago SSA 16 boundaries whose properties sustained damage due to vandalism or looting.

**APPLICATION PERIOD & LOTTERY CLAUSE**

Program is open and accepting applications starting June 5th 2020 and closing July 31st 2020. Any applications submitted after July 31st 2020 will not be accepted into the application pool. If funds are still available after the application period is closed, a subsequent application period could be announced.

In the case that there are more applicants than funding available, applicants will be entered into a lottery system.

The Greektown SSA Program Director will review the applications received. If approved, the applicants will either be reimbursed up to 100% of approved costs, up to \$1000 maximum, or in the instance there are more applicants than funding available, entered into a lottery system. Selected lottery applicants will be reimbursed up to 100% of approved costs, up to \$1000 maximum. Funding is not guaranteed to eligible applicants. The SSA Commission reserves the right to deny any Emergency Board Up Grant Application for any reason. The SSA Commission reserves the right to reject any questionable estimates, as well as implement such additional Program rules and regulations as it deems reasonable.
